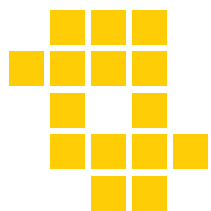

**All cloud services, software development, and continuous software evolution service-type contracts (e.g., labor) are no longer required to use CHES nor are they required to obtain a Statement of Non-Availability to use a contract outside of CHES. 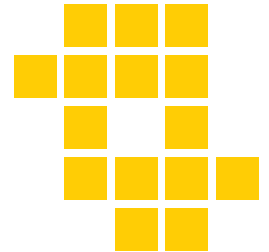

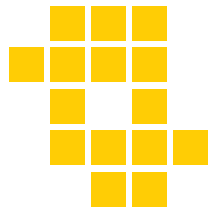
ORDERING

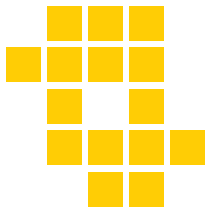

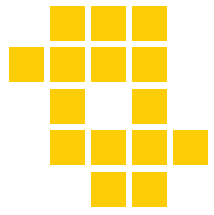

ITES-3S POST AWARD LESSONS LEARNED

- A need for a gatekeeper for scope determination at Task Orders level
- Educating Vendors on “Out of Scope” RFP responses
- Importance of RFI responses for customer market research
- With 116 Vendors, the automation of Contract Management Deliverables
- More robust Labor Categories: Artificial Intelligence/Machine Learning and Cloud Services
- Post award meeting with contractors – CHESS has an “Open Door Policy”

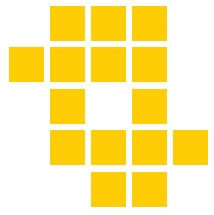

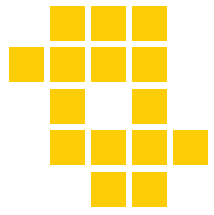

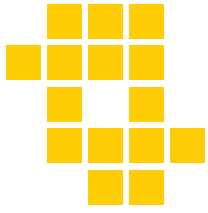




NEW ADDITIONS

- Minimum requirements for Vendors to have on their forward-facing Websites

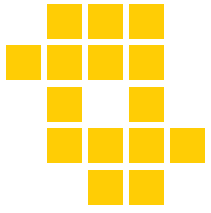

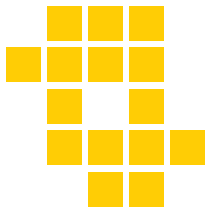

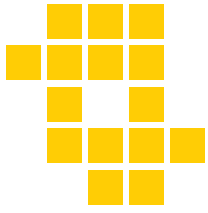


ON RAMPING

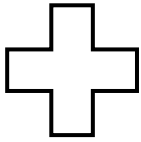
CHESS contracts are competitively awarded in accordance with the FAR

- The Government reserves the right to reopen competition on either an unrestricted basis or restricted to small businesses, at any time during the term of the contract.
- The Government will review the need for additional Contractors to ensure a sufficient amount of viable/competitive unrestricted and/or small business vendors, and/or to ensure that the agency maintains access to the latest technological solutions in contracts for IT hardware, software and services.
- At this time, there are no on ramping opportunities for CHESS contracts. Vendors that are not CHESS contract holders should consider subcontracting with a current prime. Details regarding selling to the Army and more can be found on the IT E-Mart.
- The Government reserves the right to review all contracts under a multiple award IDIQ vehicle on an annual basis to determine if it is appropriate to remove existing contractors. However, the Government may conduct an off-ramp at any time during the life of the contract.

RFI & GATEKEEPER ROLE



Importance of RFI Responses:

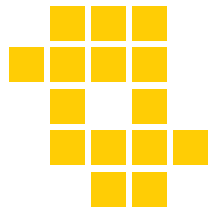
ITES-3S is mandatory

- Acquisition strategies are being determined from the RFIs that are submitted

Importance of Gatekeeper:

CHESS anticipates this to continue ITES-4S

- Since the mandate, there is review of RFI metrics and **not** just RFPs



PROPOSAL TIPS

- Minimize fluff
 - Address specifics on the RFP
 - Speak to benefits to Government
- Keep communications with past performance POCs
 - Government POCs are prepared to give good feedback
- Review previous RFPs
 - Be knowledgeable and prepared for requirements
- Work together!
 - Network and use teaming opportunities to prepare
- Review and respond the Draft RFP
 - Ensure the final is the ***final*** version
 - This will minimize amendments
- Ensure certifications are up-to-date on SAM.gov
